You can now view and download/print your IRS tax return transcript online immediately by following the step-by -step instructions below. This service is free of charge from the IRS. Please disable all pop-up blockers!

- 1. Direct your web browser to <u>www.irs.gov/transcript</u>. Choose Get Transcript Online.
- 2. Click OK when prompted by the User Agreement.

3. Click Create an Account.	 Enter your first name, last name, and email address. Click Send Email Confirmation Code link to submit.
