- Supplemental Life Insurance: Full-time employees may purchase supplemental life insurance coverage of up to \$200,000.00. Coverage is also available for spouses, domestic partner and dependent children.
- Long Term Disability Insurance: LTD is currently carried through Prudential and premiums are fully paid by the College.
- Short-Term Disability: The College also the pays the full cost of a self-funded STD benefit.
